ORDER TO SHOW CAUSE

THIS MATTER having been opened to the Court by St. Mary's Hospital, Passaic, N.J. ("St. Mary's," the "Hospital" or the "Petitioner"), by and through its attorneys, Drinker Biddle & Reath LLP, and the Report of the Acting Attorney General dated June 13, 2014 (the "AG Report"), and the Court having considered the Verified Complaint and Brief in support of the application, and the Court having determined that this matter should proceed by way of Order to Show Cause; and for good cause shown:

IT IS ORDERED on this 24th day of June, 2014:

1. Any interested party must show cause before the Honorable Margaret Mary McVeigh, P.J.Ch., Superior Court, Chancery Division, at the Passaic County Courthouse, 77 Hamilton Street, Room 621, Paterson, New Jersey 07505, on the 23rd day of July at 2 p.m., or as soon thereafter as counsel may be heard, why a final judgment should not be entered approving the application of St. Mary's for this Court's approval, pursuant to N.J.S.A. 26:2H-7.10 *et seq.*, of the proposed sale of the assets owned by St. Mary's to Prime Healthcare Services – St. Mary's Passaic, LLC ("Prime St. Mary's"), a limited liability company organized under the laws of Delaware.

2. A copy of this Order to Show Cause, the Verified Complaint, the AG Report and the Brief in support thereof shall, ^{within seven days of this order} on June _____, 2014, be served by overnight delivery or personal service on the Acting Attorney General of New Jersey, to the attention of Deputy Attorney General Jay A. Ganzman, Esq. at the Hughes Justice Complex, 25 West Market Street, Trenton, New Jersey 08625-0106.

3. A copy of this Order to Show Cause, the Verified Complaint, the AG Report and the Brief in support thereof shall, ^{within seven (7) days of this order} on June _____, 2014, be served by overnight delivery or personal service upon the persons on the Service List attached hereto as Exhibit A, who have filed written comments and/or appeared and made a statement at the public hearing conducted in this matter, other than those appearing as a representative of the parties to the transaction.

4. A copy of the notice attached hereto as Exhibit B (the "Notice") shall, ^{within seven (7)} on June _____ ^{day of this order}, 2014, be served by ordinary mail upon the individuals who submitted postcard comments on the transaction or signed petitions, who are identified on Exhibit C attached hereto. As provided in the Notice, St. Mary's shall make available for public inspection and review at St. Mary's Hospital, 350 Boulevard, Passaic, New Jersey 07055, and shall post on its website, <http://www.smh-passaic.org>, a copy of this Order to Show Cause, the Verified Complaint, the AG Report and the Brief in support thereof, and all other papers that are submitted to the Court in this matter.

5. St. Mary's will cause notice in the form attached as Exhibit D to be published one time in The Record and the Star Ledger, two newspapers of general circulation in Passaic County, as soon as practicable and no later than ^{JULY 7th} June _____, 2014. Exhibit D shall also be translated into Spanish and published one time in El Especial, a Spanish language newspaper

of general circulation in Passaic County, as soon as practicable and no later than ~~June~~ ^{July 7th} _____
_____, 2014.

6. Any objection or other written response to the relief sought by the Verified Complaint must be filed with the Court and served upon St. Mary's counsel to the attention of Frank F. Velocci, Esq., at Drinker Biddle & Reath LLP, 600 Campus Drive, Florham Park, New Jersey 07932, with a copy to the Acting Attorney General of New Jersey, to the attention of Deputy Attorney General Jay A. Ganzman, Esq. at the Hughes Justice Complex, 25 Market Street, Trenton, New Jersey 08625-0106, by overnight delivery or personal service on or before July 15th, 2014.

7. If no interested party serves and files an objection to the relief sought in the Verified Complaint within the time set forth herein, judgment shall be entered for the relief sought in the Verified Complaint.



You are not required to participate in the hearing or to respond to this notice if you do not want to do so.
